**Describe the data that analyzed to determine the effectiveness of the program and decisions made as a result:**

The following achievement tests are utilized: Renaissance Star Suite Math/Reading benchmarks (K-6, 3x/yr) This also includes Progress Monitoring using CBMs (which are a measure of progression for specific skills in both reading and math), NSCAS at the appropriate and required grade levels, and STAR Reading Assessment (K-6, quarterly, primarily for the Accelerated Reading program). Renaissance Star Early Literacy/Star Reading assessments are used to determine if any K-3 student requires a Reading Improvement Plan per the Nebraska Reading Improvement Act. Teachers also use the curriculum based measures from their reading (K-5, Into Reading, 6th, EB Benchmark Assessments) and math (i-Ready) series to assess students' growth across the curriculum.

Changes were made to include the new CIP goal and an update of assessments used. PD was different from before so changes were made to mention those. There were also changes made to the high school wolf time schedule as it has changed since it first began.

**In the box below give information that was discussed during the review (Meeting Minutes):**

We currently utilize an Exploration period at the end of the elementary school day and it has been discussed many times in teacher's meetings this school year about changing its format or cutting Explorations time out completely. Appropriate PD was also discussed as we move to make changes in our assessment tools next year with K-3 Dibels for IRIPs and back to using the NWEA math and reading.
